Date: November 19, 2016 Weekly Council Update

- **Two More Weeks of Leaf Collection:** Leaf collection begins at approximately 7:30 am on the east side of town every Monday, Wednesday and Friday. While Public Works makes every attempt to reach the whole town each day, occasionally leaf collection cannot be completed in one day. During those times Public Works will do another collection the following day for residents that could not be picked up the previous day. The City asks that leaves be raked to the curb for pickup and be free of tree limbs, sticks, grass clippings and garbage. Leaves mixed with other yard waste or placed in plastic bags will not be accepted.

The City's Public Works department will continue leaf collection until December 2nd. After that time residents can haul yard waste to the City collection site located a half mile east of S Downey Street on Fawcett Drive. The City does not accept yard waste in plastic bags, any kind of construction material, garbage, dirt or rock in this area. Also as a reminder, the City's final curbside yard waste collection of 2016 will take place on Thursday, December 1st. Yard waste includes grass clippings, leaves, wastes common in gardening or landscaping, clippings from bushes or shrubs, sticks and tree limbs. All limbs too large for a container must be cut to under 4 foot lengths and be in manageable bundles at the curbside. All other yard waste must be bagged or placed in a container at the curbside. All containers must be under 50 pounds and any bag used must be a decomposable bag. Any yard waste in plastic bags will not be accepted.

- **S. Downey Road Improvements:** Crews from All American Concrete completed a large portion of the remaining work on S. Downey in front of McDonald's and Kum N Go this week. Paving on the west side of S. Downey has been completed, including the trail from I-80 to the intersection of S. Downey and Tidewater Drive. Next week, crews will backfill curbs, put down permanent striping and pull traffic control. Weather permitting, an attempt may be made to hydro-seed as well. In the event that the hydro-seeding is unsuccessful due to the weather, crews will seed these areas again in the spring.

- **Next City Council Meeting – November 28th:** As a reminder, the regular City Council Meeting scheduled for Monday, November 21<sup>st</sup> has been postponed until Monday, November 28<sup>th</sup> at 7:00 p.m. The December meeting schedule will be determined at the November 28<sup>th</sup> meeting.

- **Christmas Past:** Celebrate the holidays with an old-fashioned Christmas celebration in downtown West Branch. West Branch CDG is sponsoring Christmas Past on December 2nd and 3rd. - Fiscal Year 2017-2018 Annual Budget:** City Administrator Matt Muckler and Finance Officer Gordon Edgar attended the 2016 Budget Workshop sponsored by the Iowa League of Cities earlier this week in Cedar Rapids. Budget projections and issues were presented by Mickey Shields, Iowa League of Cities and Cindy Kendall, Iowa State University Extension - Office of State & Local Government Programs. The new multi-residential property class rollback schedule was discussed, as were rollback numbers and road use tax fund distribution for the next five fiscal years (please see below). The CPI, the FLSA Exempt Employee Rule Change, and the Employment Cost Index were also presented. The Employment Cost Index measures the change in the cost of labor for state and local government workers from September of 2015 to September of 2016. Total compensation costs rose 2.6% during this time.

The new multi-family residential property class will be implemented over an 8-year period and will not be backfilled:
